Developmental Disabilities (DD) Waivers Rate Changes Effective January 1, 2021

This bulletin (which supersedes the bulletin dated December 16, 2020 entitled, "Developmental Disabilities (DD) Waivers Rate Changes Effective January 1, 2021") is a REVISION to the previous bulletin.

The purpose of this bulletin is to inform providers that rates for group home, sponsored residential, and day support services will increase, effective January 1, 2021. Pursuant to 2020 Special Session I Amendments to the 2020 Appropriation Act, Item 313 DDDD(1), the Department of Medical Assistance Services (DMAS) in consultation with the Department of Behavioral Health and Developmental Services (DBHDS), will increase provider payment rates for services delivered through the Community Living, Family and Individual Support, and Building Independence Developmental Disability (DD) waivers. The rate increase shall be provided for the following services: Group Home, Sponsored Residential, and Group Day Support. The rate changes are shown in the tables below and will be posted on the DMAS website at: https://www.dmas.virginia.gov/#/waiverservices.
