Medicaid Home Health Care Services (HHCS) Electronic Visit Verification (EVV) Project Update

The Department of Medical Assistance Services (DMAS) received a Good Faith Extension from the Centers for Medicaid and Medicare Services (CMS) to implement Electronic Visit Verification (EVV) requirements for Home Health Care Services (HHCS) on July 1, 2023. DMAS has published an 837I companion guide on DMAS website at https://www.dmas.virginia.gov/for-providers/long-term-care/programs-and-initiatives/electronic-visit-verification. This guide is important for your billing system to submit HHCS claims compliant with Virginia's EVV requirements. Virtual trainings will be available to providers of Home Health Care services beginning in February 2023. The managed care plan may utilize different guidelines than those described for Medicaid fee-for-service individuals.
