Revised Outpatient Hospital Rates - Effective July 1, 2022

The purpose of this bulletin is to notify providers that the rates for outpatient hospitals have been revised for state fiscal year 2023 (SFY23) effective for dates of service on or after July 1, 2022. Enhanced Ambulatory Patient Groups (EAPG) base rates have been recalculated to include all claim experience data in accordance with 12VAC30-80-36. There will be no changes to the EAPG grouper version 3.16 weights. The Department of Medical Assistance Services (DMAS) will reprocess Fee-For-Service claims.
