## Developmental Disabilities (DD) Waivers Rate Updates Effective July 1, 2021

The purpose of this bulletin is to inform providers of rate updates to DD Waiver services including Independent Living Supports, Supported Living, In-home Support Services, Group Supported Employment, Workplace Assistance, Community Engagement, Community Coaching, Therapeutic Consultation, select Group Day Support, and select Group Home services. Rate updates have been made in consultation with the Department of Behavioral Health and Developmental Services (DBHDS) in accordance with the 2021 Virginia Acts of Assembly Item 313.DDDD. The rate changes are shown in the tables below and will be posted on the DMAS website at: <https://www.dmas.virginia.gov/for-providers/long-term-care/waivers/>.

### **DD Waivers Rate Changes Effective July 1, 2021**

In accordance with Item 313.DDDD.2 rates for Independent Living Supports, Supported Living, In-home Support Services, Group Supported Employment, Workplace Assistance, Community Engagement, Community Coaching, and Therapeutic Consultation have been increased. **Please note Community-Based Crisis Supports (H0040) will move to procedure code S9484 for dates of service on or after July 1, 2021.** Procedure code H0040 will be used for Assertive Community Treatment (ACT) for dates of service on or after July 1, 2021. Refreshed DD Waivers rates effective on and after July 1, 2021 are found in the table below.
