MEDICAL DIRECTOR'S FEES

Costs will be allowed up to the established limit per year to the extent that such fees are determined to be reasonable and proper. This limit will be escalated annually by the Consumer Price Index (all urban) January 1 of each calendar year to be effective for all providers' cost reporting periods ending on or after that date. The limits will be published annually. The following limits apply to the time periods as indicated:

MANAGEMENT FEES

Limits will be based upon comparisons with other similar size facilities and/or other DMAS guidelines and information, or both.

Effective for all cost reporting periods ending on or after October 1, 1990, a per-patient-day ceiling for all full service management service costs was established. The ceiling limitation for cost report periods ending on or after October 1, 1990, through December 31, 1990, was the median per-patient-day cost as determined from information contained in the most recent cost reports for all providers with fiscal years ending through December 31, 1989. For subsequent years, these limits are adjusted annually by the Consumer Price Index (all urban) effective January 1 of each calendar year to be effective for all provider cost reporting periods ending on or after that date. The limits are published and distributed to providers annually.
